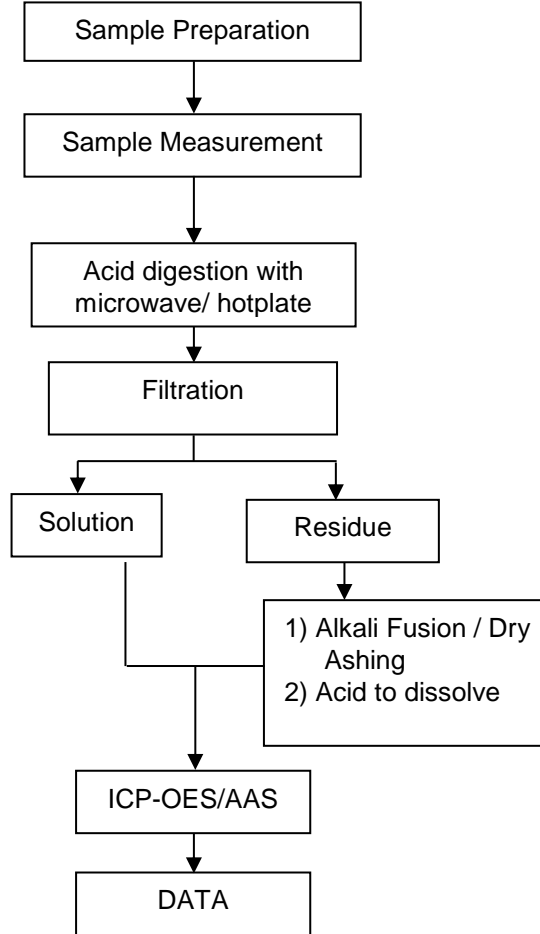

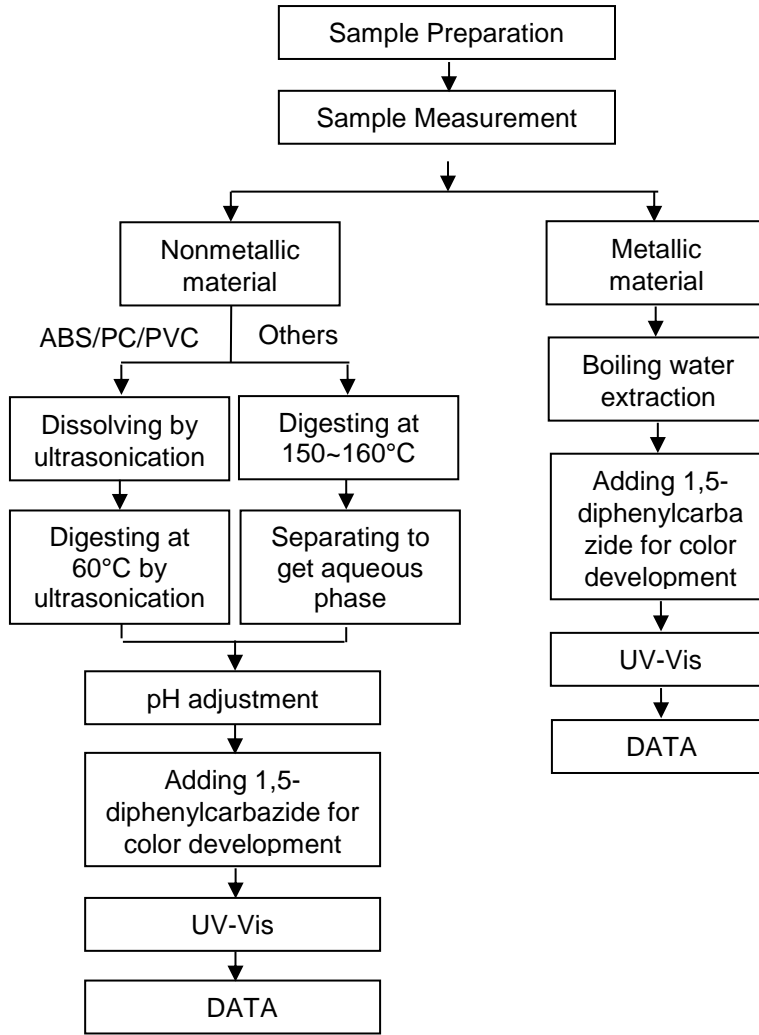

These samples were dissolved totally by pre-conditioning method according to below flow chart.

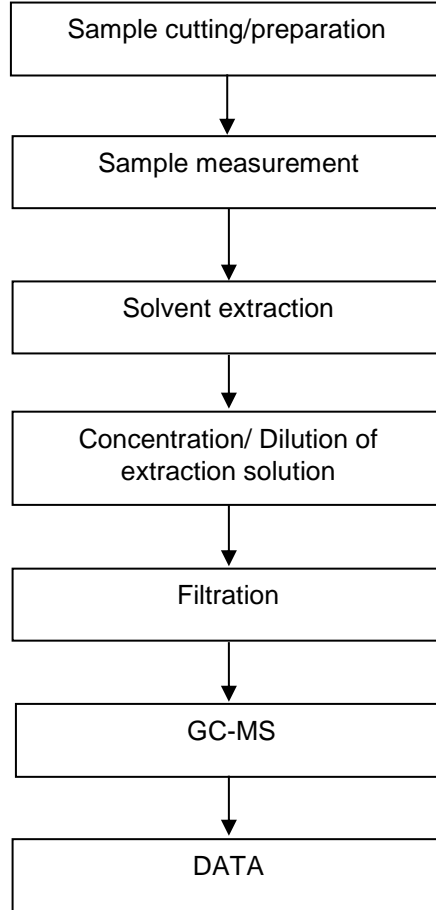


**Hexavalent Chromium (Cr(VI)) Testing Flow Chart**

### Phthalates Testing Flow Chart



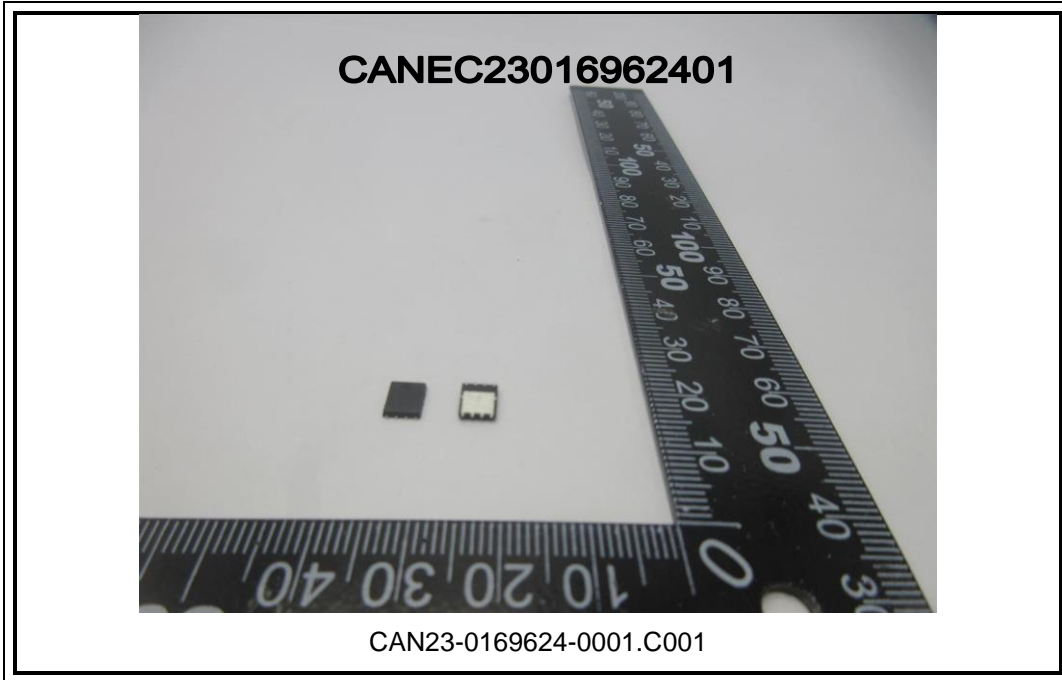
